

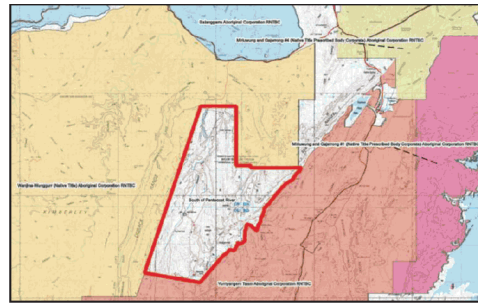

#### What is the meeting about?

- 1 how a native title claim can be made over the area outlined in red on the map;
- 2 field work with Dr Tony Redmond planned for April – May 2024; and
- 3 a Heritage Impact Assessment (HIA) notice for environmental studies planned in the area by Speewah Mining Pty Ltd / Tivan Limited.
