## STERILISATION & MICROCHIPPING

It is required by the Shire of Derby / West Kimberley that you sterilise and microchip your cat(s).

- Proof of sterilisation is required, in the form of either: Veterinary surgeon's certificate
- Signed statutory declaration
- Ranger sighting of an ear tattoo and/or request cat to be scanned for proof of microchip

Please provide a photocopy of sterilisation and microchipping evidence.

If the cat(s) is/are not sterilised, the exemption must be granted by a veterinarian.

Please provide exemption letter from the animal/s' veterinarian.

## IMPORTANT:

All cats aged six (6) months and over must be registered, microchipped and sterilised in accordance with the Cat Act 2011. Penalties apply for not complying with the Act.
